What a race!

What a one-eighty in how the two candidates present themselves!

I received my copy of Lt. Mike Hernandez's letter in the mail just now, much later than most others. My reaction to the letter was the word "hoodwinked." It presents itself as being full of ideas that will make a world of difference in our community. While it is simply reporting what is already in operation as being "new," it hoodwinks the reader into believing they are reading something which would be implemented if he is elected.

I want to look at this journey we've been on (recap) and address a few things from this letter Hernandez has sent out to the voters in our city. I believe this is a critical election for San Angelo. CHAPTER 150. MISCELLANEOUS PROVISIONS AFFECTING MUNICIPAL OFFICERS AND EMPLOYEES

SUBCHAPTER A. INVOLVEMENT OF FIRE FIGHTERS AND POLICE OFFICERS
IN POLITICAL ACTIVITIES

Sec. 150.001. APPLICATION OF SUBCHAPTER TO CERTAIN MUNICIPALITIES WITH POPULATION OF 10,000 OR MORE. This subchapter applies only to a municipality with a population of 10,000 or more, but does not apply to a municipality in which Chapter 143 applies.

Added by Acts 1989, 71st Leg., ch. 1, Sec. 34(a), eff. Aug. 28, 1989.

Sec. 150.002. POLITICAL ACTIVITIES. (a) While in uniform or on active duty, an employee of the fire or police department of the municipality may not engage in a political activity relating to a campaign for an elective office.

- (b) For the purposes of this section, a person engages in a political activity if the person:
- (1) makes a public political speech supporting or opposing a candidate;
- (2) distributes a card or other political literature relating to the campaign of a candidate;
 - (3) wears a campaign button;
 - (4) circulates or signs a petition for a candidate;
 - (5) solicits votes for a candidate; or
 - (6) solicits campaign contributions for a candidate.

One of the comments I hear over and over is the difference in the number of years Hernandez has over Griffith. That may be very true. He may beat Griffith in receiving a gold watch at retirement time, but that has nothing to do with being a leader.

Hernandez's campaign team has been trying to put Griffith down because he is "only" a Sergeant. Let's keep in mind, Chief Carter is the first person in decades to be elected Chief who was a lieutenant. They have all been Sergeants. That has never been an issue, until someone needed for it to be.

I've heard and read posts by various officers as they expose things that are being said by Hernandez to garner votes which are very misleading. This was on my mind as I read the letter his campaign sent to my home.

Interesting – out of all the private emails, notes, texts, and phone calls I have received, not one of them was trying to give me detrimental information on Cimino or Griffith. Every one of them was

about Hernandez. Do note, I never asked anyone through any means to contact me and share the information they did. Some things were very disturbing.

So, it's my turn to question parts of the letter I received in the mail. [I have posted the bulk of the verbiage from the letter as a postscript to this article, as I want to be sure no one thinks I pulled any information out of context.]

Operation Spotlight – questioning suspicious people during the night

- Is this not the definition of policing? If you see something suspicious, you check it out. Working from home, I see lots of suspicious activity all throughout the day. Why are you just targeting the deep night shift?
- Former candidate for Chief, Lt. Chris Cimino commented, "The principle of "Operation Spotlight" is already going on. Police officers have been doing this on a daily basis since the inception of modern policing by Sir Robert Peel back in the 1800's. It's called Patrol."

Security Video Initiative – people reporting people on their video

- I am all for working smarter and using technology where it can be advantageous, but I don't think citizens are ready for San Angelo to become BIG BROTHER. China and other foreign countries use all these cameras to control their citizens. That is not what America is all about.
- As it is now, do we not have a means to submit video footage to the SAPD if the need arises? I do believe we do. So, are you just creating a new department, and where are you going to go to find people to man this new department who will be watching and categorizing all this footage? Manpower seems to be a shortage.

Uninsured Motorist Ordinance

 While this might sound like a possible solution, my first reaction is Big Brother is seizing property on the spot without a trial or jury of my peers hearing the case. Driving without insurance is a misdemeanor, I believe. You could be taking something of greater value than the actual fine they would receive. Is that the

- right thing to do? I'm all for fighting against uninsured drivers, but this doesn't seem like the right solution.
- Would the City be prepared to take on the lawsuits that might ensue?

School Safety

- SAPD has been actively involved on campuses all the way back to when I was in school in the 60's and 70's.
- There is nothing new being mentioned here.

Mom and Pop Businesses

• I'm not seeing anything new being mentioned here either.

Next Administration – what it does internally

- Gut reaction I see red flags all over this. Our manpower shortage is very real and the aftermath of these chiefs' elections could easily make it worse. Aftermath are you suggesting that you might terminate your rivals, adding to the shortage in manpower that already exist? I understand you cannot directly fire your opponents, but you can reassign them and downgrade their pay, causing them to choose to leave.

I don't know about you, but my tax dollars are not appreciated when used for working from home, deep sea fishing, traveling all over the U.S., etc. If you no longer want to serve in a position, then resign and allow us to find someone who does. Running out the clock so you can get the highest retirement pay possible at our expense isn't the right thing to do. We will be watching more closely in the years to come.

San Angelo, we have been asleep at the wheel and played in various ways. It is time to wake up, get involved, and hold our elected officials accountable – and the employees of our great city, as well. If we want

One such strategy is, "Operation Spotlight". We have individuals methodically prowling San Angelo neighborhoods at night, checking car doors and stealing any valuables they can get their hands on. In my initiative, late night patrol officers will be proactively looking for people on foot, wearing clothing that can conceal their identity and carrying packs with which to transport stolen items. We will not search or detain anyone unless there is legal cause. However, we will make contact, ask for their ID, and make note of them. We need these individuals to be painfully aware that we are watching them, and we know who they are. Intense scrutiny is the best deterrent to crime. It's a strategy I have worked with in the past for gang activity, and it works. Let's turn on the light and make them scatter.

This ties in to a security video initiative, in which we want to partner with you! I believe that the new prevalence of web based camera systems can be a great opportunity for Crime Analytics. While we can't currently afford to install city wide "CCTV" like they utilize in many parts of Europe, we can adapt their techniques and apply them to data provided by homeowners. I will have an online portal added to our website specifically for you to upload your videos of trespassers, suspicious activity, and especially of individuals attempting or committing a crime. Our crime analysts will take a more formal approach to cataloguing and analyzing this footage. We can use it to find patterns for crime prevention and provide supporting materials for arrests and convictions.

I don't have to tell you that insurance costs are soaring. Law abiding drivers pay more and more while irresponsible drivers are just less likely to pay for coverage. We are not utilizing our legal ability to maximize the repercussions for ignoring this law. I want to work with the City Council to create, adopt, and implement an Uninsured Motorist Ordinance. Under this

Ordinance, uninsured drivers stopped or involved in an accident can have their vehicles towed and impounded at their expense. Many other Texas cities already have such an ordinance. Odessa adopted a UMO last year, in response to estimates that 40% of Permian Basin drivers were uninsured. Let's address this problem in our city right now— before the problem gets that bad.

School safety is a priority for my first 100 days, as it has been throughout my career. I spent 25 years as a Campus Resource Officer, and have taught countless readiness courses to educators. I have seen the importance of positive interaction between law enforcement, faculty and students, and how it benefits our school campuses and our streets. In my administration you will see a proactive cooperation between SAPD and San Angelo's public and private schools.

I also appreciate the absolute importance of our businesses. From "Mom and Pop" shops to the large scale construction sites, business relies on a secure community to thrive. Business owners can expect to have my attention as well.

What the next administration does internally is equally important for San Angelo's best interests. Our manpower shortage is very real and the aftermath of these chiefs' elections could easily make it worse. However, I understand that the zeal officers bring to these campaigns is the same zeal with which they care about the department and our community. I appreciate that their livelihoods are in the balance. In every way I can, I will demonstrate to my opponents and their supporters that they remain honored and integral members of the SAPD family.
